Achieving long-term capital growth with predefined and controlled levels of risk, by investing in stocks listed on the Saudi stock exchange (Tadawul). In addition, the fund will aim to achieve returns that exceed the average by benefiting from the expected economic growth in Saudi Arabia while maintaining a suitable level of diversification for fund assets and reduction of total risk by investing in different market sectors.

c. Definitions

- 1) **Standard Deviation:** A standard deviation is a statistic that measures the dispersion of a dataset relative to its mean. The standard deviation is calculated as the square root of variance by determining each data point's deviation relative to the mean.

- 2) **Sharp Ratio:** The ratio is the average return earned in excess of the risk-free rate per unit of volatility or total risk. Volatility is a measure of the price fluctuations of an asset or portfolio.

- 3) **Tracking Error:** Tracking error is the divergence between the price behavior of a position or a portfolio and the price behavior of a benchmark. Tracking error is reported as a standard deviation percentage difference, which reports the difference between the return an investor receives and that of the benchmark they were attempting to imitate.

- 4) **Beta:** Beta is a measure of the volatility—or systematic risk—of a security or portfolio compared to the market as a whole. Beta data about an individual stock can only provide an investor with an approximation of how much risk the stock will add to a (presumably) diversified portfolio.

- 5) **Alpha:** Alpha refers to excess returns earned on an investment above the benchmark return. Alpha may be positive or negative and is the result of active investing.

Tadawul was down 1.86% during the quarter, despite continued strong oil prices and better than expected Q3 market earnings due to profit booking and concerns over emergence of a new corona variant. The Fund outperformed during this period despite being defensively positioned with a high cash buffer.

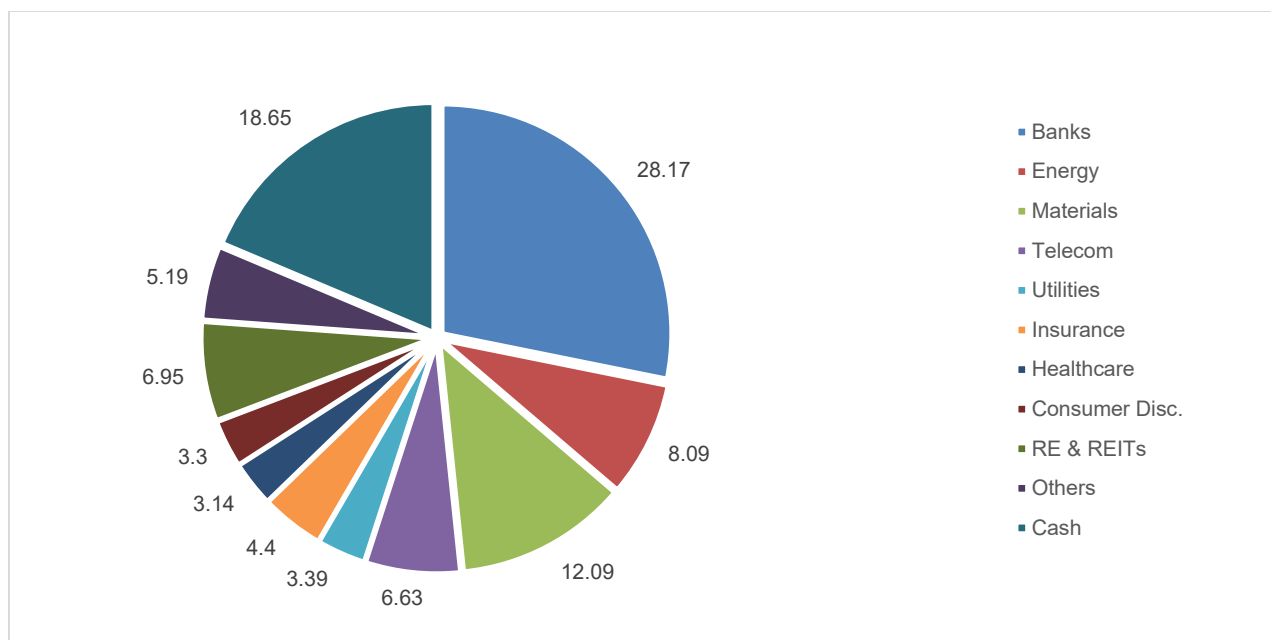
