Achieving long-term capital growth with predefined and controlled levels of risk, by investing in stocks listed on the Saudi stock exchange (Tadawul). In addition, the fund will aim to achieve returns that exceed the average by benefiting from the expected economic growth in Saudi Arabia while maintaining a suitable level of diversification for fund assets and reduction of total risk by investing in different market sectors.

c. Definitions

- Standard Deviation: A standard deviation is a statistic that measures the dispersion of a dataset relative to its mean. The standard deviation is calculated as the square root of variance by determining each data point's deviation relative to the mean.

- 2) **Sharp Ratio:** The ratio is the average return earned in excess of the risk-free rate per unit of volatility or total risk. Volatility is a measure of the price fluctuations of an asset or portfolio.

- 3) Tracking Error: Tracking error is the divergence between the price behavior of a position or a portfolio and the price behavior of a benchmark. Tracking error is reported as a standard deviation percentage difference, which reports the difference between the return an investor receives and that of the benchmark they were attempting to imitate. - 4) **Beta:** Beta is a measure of the volatility—or systematic risk—of a security or portfolio compared to the market as a whole. Beta data about an individual stock can only provide an investor with an approximation of how much risk the stock will add to a (presumably) diversified portfolio. - 5) Alpha: Alpha refers to excess returns earned on an investment above the benchmark return. Alpha may be positive or negative and is the result of active investing. (https://www.investopedia.com/terms/a/alpha.asp)
- 6) **Information Ratio:** Information ratio (IR) is a measurement of portfolio returns beyond the returns of a benchmark, usually an index, compared to the volatility of those returns. The IR is often used as a measure of a portfolio manager's level of skill and ability to generate excess returns relative to a benchmark.

d. Fund Managers Comments

Tadawul was up 8.24% during the quarter as investor sentiments revived post benign inflation and dovish Fed comments on future course of rates. Despite a challenging regional backdrop, Banks rallied aggressively during the quarter as market expectations for more 100bps rate cuts in 2024 boosted sentiments. The Fund outperformance during this period was due to over-weight position in Banks and underweight in Materials.




